

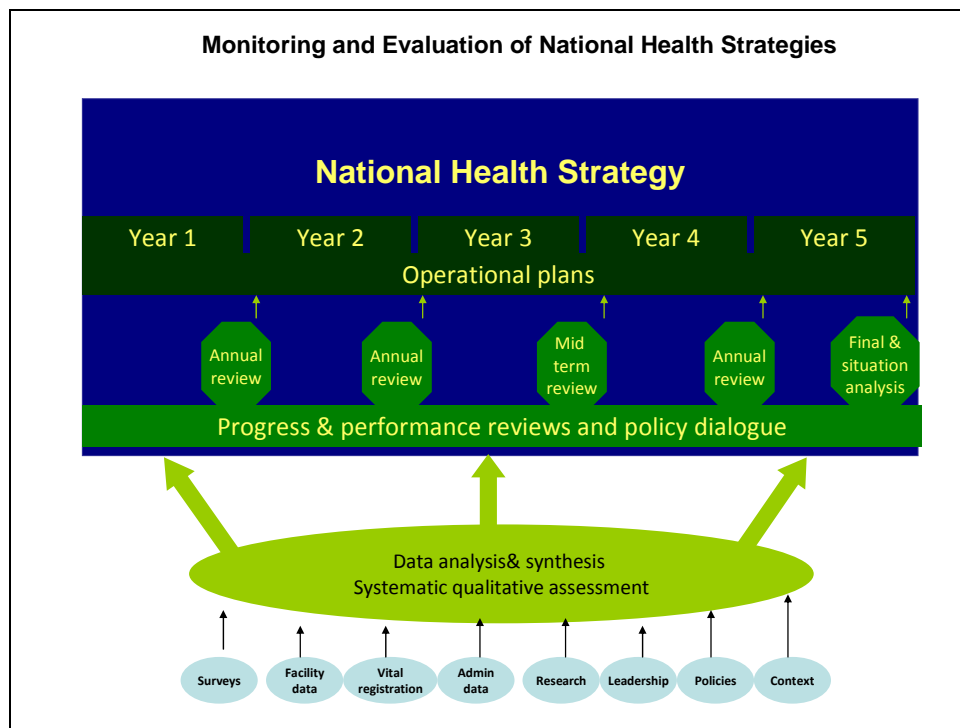
Moving towards one country-led Monitoring & Evaluation platform for national health strategies¹

One strong country monitoring and evaluation (M&E) platform as part of the national health strategy, policies and plans is the foundation for accountability. M&E informs the progress and performance reviews, including annual health sector and programme reviews, mid term and final reviews. M&E also informs the policy dialogue and influences the development and implementation of short term operational plans as well as long term plans.

The M&E platform should meet a set of minimum criteria, related to the use global standards, transparency, data quality and country institutional roles and responsibilities. Global partners should align themselves with the one country-led M&E platform, including investing in it and minimizing parallel reporting systems. Disease-specific M&E systems should also be part and parcel of the national M&E platform. The importance of a strong monitoring and review platform is emphasized in the Joint Assessment of National Strategies (JANS) approach.

In the Brussels meeting, three sets of questions will be addressed:

1. What are the main challenges / obstacles to implementing this platform?
2. What can be done to overcome those challenges?
3. What are the main recommendations on next steps?



Based on a series of consultations involving many countries and international partners, the following elements and characteristics are considered desirable for a national M&E platform:
